


20/8/13	<p align="center"></p> <p>The instant jamabandi cancellation case has been started on the basis of the report received from Anchal Adhikari, Bhithaha vide letter no.409 dated. 17-12-12 The Anchal Adhikari, Bhithaha has made available copy of concerned page of jamabandi Register-ii bearing jamabandi no. 228, mauza- Khaira The instant jamabandi was dubbed doubtful vide District Magistrate's order no. 170, dated- 02.08.2002.</p> <p>“The same jamabandi bears a red stamp containing (detailing) following description :- “समाहर्ता, पश्चिम चम्पारण के आदेश संख्या 170 दिनांक 02. 08.2002 के आलोक में यह जमाबंदी संदिग्ध पाई गई है। सूची जॉच हेतु प्रेषित। रसीद अगले आदेश तक निर्गत नहीं करें”</p> <p>Notices were issued to the jamabandi holders/his legal heirs to show papers/document on 08.03.2013, on the basis of which instant jamabandi of gairmazarua khas land was started.</p> <p>The Anchal Adhikari, Bhithaha has reported that the land inquestion khata no. 871, khesara no.5680 area- 0-4-0 Dhur, mauza- Khaira Anchal- Bhithaha is recorded in the survey khatian as gairmazarua malik. Moreover, as per report received from Anchal Adhikari, Bhithaha, the said jamabandi of govt land was started vide restoration case no. 46/91-92</p> <p>Heard jamabandi raiyat/his legal heirs on 08.03.2013 in the Bhithaha Anchal office and also perused various papers enclosed with the record. The jamabandi raiyats/his legal heirs produced rent receipt issued during financial year 92-93 The jamabandi raiyats/his legal heirs failed to show papers related to the settlement of above govt. land in the name of Kutubdin Miya As the land is recorded as gairmazarua Malik in the survey khatian which was not properly settled either by the ex-landlord or competent authority vested with the power of settling gairmazura khas land. hence instant jamabandi running on the basis of restoration case no. 46/91-92 is set aside to the finding as above and Anchal Adhikari, Bhithaha is directed to restore govt. control over the said land bearing khata no. 871, khesara no.5680 mauza Khaira area 0-4-0 Dhur</p> <p align="center"> Additional Collector, West Champaran, Bettiah.</p> <p align="center"> 20/8/13</p>
