The instant jamabandi sudhar case has been started on the basis of the report received from Anchal Adhikari, Gaunaha vide letter no. 522, dated 15.09.2012. The Anchal Adhikari, Gaunaha got the matter inquired by Halka Karamchari and Circle Inspector in pursuance of an application submitted by the petitioner Alam Ara Khatoon.

Notices were issued to both the parties. The respondents repeatedly prayed for time to submit rejoinder and finally failed to submit his rejoinder. The Halka Karamchari has mentioned in his report that jamabandi of the land in question was earlier running in the name of petitioner's father. The details of the above jamabandi runs as follows:-

New Jamabandies numbering 645 and 646 were created vide mutation case nos. 1424, 1425/06-07 after deducting 0-16-04 bighas land from original jamabandies and only 0-00-14 bighas land remained in the original jamabandi.

After above mutations new jamabandies numbering 645 and 646 were created, which have their following nature :-

As per report received from Anchal Adhikari, Gaunaha khata no. 159, khesara no. 23 and 200 is recorded as gairmazarua thekedar nature- Partikadim in the Survey Khatian. The respondents failed to submit any paper related to the

settlement of above gairmazarua land either by the ex-landlord or by the govt. These simply show that jamabandi of khesara no. 23 and 200 (that of govt. land) were started by sheer manipulation. Hence jamabandies started vide mutation cases numbering 1424 and 1425/2006-07 is cancelled to the findings as above. The petitioner and respondents are advised to submit mutation applications in the Anchal Office through RPTS counter and Anchal Adhikari. Gaunaha is directed to examine such mutation applications threadbare as per laid provisions and pass reasoned and speaking orders. In no case govt. land should be mutated in any body's name.
