27.4.12	<p style="text-align: center;"><u>COURT OF THE DISTRICT COLLECTOR</u> <u>WEST CHAMPARAN</u></p> <p style="text-align: center;">RM-47/11-12 Nitu Kumari Vs State of Bihar and others</p> <p style="text-align: center;"><u>ORDER</u></p> <p>1 This appeal has been filed against the order of District Programme Officer, ICDS, West Champaran vide letter no 116 dated 24.10.2011 whereby the selection of appellant Nitu Kumari w/o Akhileswar kumar verma as anganwaadi sevika of Centre no 117 at Village Pokhra tola, Rampur of Nayagaon was terminated.</p> <p>2. Heard all concerned and perused all the documents on record.</p> <p>3. SDO, Bagaha got inspections of anganwaadi centers done on 15.2.11 and reported vide letter no 199 dated 17.2.11 irregularity of THR distribution at various centers. The DPO, ICDS issued show cause to concerned Sevikas.</p> <p>4. Accordingly, show cause also was issued to Nitu Kumari center no 117. She submitted her show cause which was found unsatisfactory and her selection was terminated.</p> <p>5. The charges against appellant were that she did not draw the money for purchase of ration despite having money in the bank account and that she did not distribute THR as per norms.</p> <p>6. The appellant submitted the passbook of poshahar samiti bearing account no 9229 of Kshetriya Gramin Bank, Patkhauri of Bagaha 2 which clearly shows that money was withdrawn on 12.2.11, disproving the charge of nondrawl.</p> <p>7. The appellant also submitted photocopy of THR register claiming that the distribution was done on the said date as per norms. Senior deputy collector, Bagaha</p>

-2 was directed to do a field verification of the photocopy submitted. The verification report vide letter no 26 dated 3.3.12 clearly finds that money was withdrawn and distribution as per the register was found to be correct.

8. Thus, both the charges based on which the appellant Nitu Kumari's selection was terminated stand disproved. Therefore, I hereby set aside the order of District Programme Officer, ICDS, West Champaran vide letter no 116 dated 24.10.2011 whereby the selection of appellant Nitu Kumari w/o Akhileswar kumar verma as anganwaadi sevika of Centre no 117 at Village Pokhra tola, Rampur of Nayagaon was terminated and direct that she be reinstated as Sewika of the said centre with immediate effect.

Send a copy of this order to CDPO, Bagha-2 who shall report compliance within one week.
